Metal Drop Box

WE'LL PAY YOU OUR CURRENT METAL PER TON GATE RATE MINUS A \$175 DROP BOX DELIVERY AND PICK UP FEE*

* A flat rate delivery/pick up fee of \$175 applies to most areas. Additional fees apply outside those areas

Items Allowed in Drop Boxes Must Be At Least 95% Metal

Prohibited Items:

- Solid Waste/Garbage.
- Batteries or Munitions.
- Hazardous Waste, Radioactive or Medical Waste.
- Hydraulic Accumulators or Sealed Transformers.
- Unpurged Propane Tanks & Fire Extinguishers.
- Any Engine, Motor, or Transmission or 55g barrel that is not *completely* drained.
- Items containing PCB's (Light ballasts, Capacitors, transformers)

Drop Box Sizes (H x W x L)

40 Yard: 6.5 x 7.5 x 22

30 Yard: $5 \times 7.5 \times 22$

Long 20 yard: $3.5 \times 7.5 \times 20$

Short 20 Yard: 4.5 x 7.5 x 16

A Metal Account Must Be Set Up With Us Prior To Delivery

Before we deliver you a drop box, you must show us a current government issued PHOTO ID and set up a metal account with us.

BUSINESSES: Your company must set up a commercial metal account with our office before we buy commercial metal property from you. An authorized agent from your company must set up an account with us and list all employees that are authorized to sell us metal. Photo ID and Company ID are required prior to each transaction.

WE DO NOT PURCHASE STOLEN PROPERTY

Before we buy metal from you, you must show us a current government issued PHOTO ID and you must sign a declaration that the property you're selling us is not stolen.

Additional Charges/Information: Metal Drop Box

- Drop Box Truck operation times are 7am 3:30pm Monday Friday.
- \$175 Delivery/Pick Up Fee: Borders are 1 mile South of Yachats City Limits; 1 mile east of Yachats city limits; Otter Crest; East out 20 Eddyville/Elk City/Logsden Store; North out 229 15 mile marker. Additional Delivery Fee for beyond those boundaries.
- You must contact your local Dahl Disposal Service office one day prior for removal of the box.
- All vehicles placed in drop box must have a signed Title, Bill of Sale, and fluids drained except for differentials and rearends. All paperwork is to be given to the driver.
- Rent for temporary placement is \$7.00 a day after the 7th day.
- Moving fee for coming back to move a drop box is, \$107.50 per hour, Min. \$50.00.
- You must tell us where you would like to have the drop box placed. If you are not present and we cannot place the box in the area that has been given, or you did not tell us where to place to drop box, then our driver will determine the best location.
- Driveways need to be truck accessible for drop box placement and delivery. Dahl Disposal Service is not responsible for any damage done to the property.
- Over loading boxes (over the sides) will result in additional \$25.00 per yard fee. If the box is determined to be unsafe to haul down the highway due to overloading, you will be asked to unload the box to an even height with the sides.
- There is an 11-ton weight limit on all drop boxes. Customers will be responsible for any fines incurred, and a \$200.00 penalty for any overweight boxes.
